

**Third generation farmer Kirby McLemore has a lot of experience on a tractor.**

“I have been at this a while,” said Kirby McLemore. “I started helping on the farm when I was about six years old and driving a tractor when I was nine.”

He started his own farm in 1989 with 95 acres. McLemore now farms around 2,000 acres. He farmed cotton for 20 years, but switched to corn, wheat, and soybeans five years ago.

McLemore understands what it takes to be a good steward of the land, and he is no stranger to the USDA Natural Resources Conservation Service (NRCS).

Through the years, he has installed conservation practices through the Turkey Creek 319 Water Quality Program, Environmental Quality Incentives Program, and Conservation Stewardship Program. Each practice installed has helped keep his soil intact and on his farm.

When he began to notice problems with soil health and potential issues with the quality of the water leaving his farm, he paid NRCS a visit.

Jason Hardie, NRCS District Conservationist in the Winnsboro Field Office, recommended adding cover crops to McLemore’s conservation activities. McLemore elected to plant a mixture of Australian winter pea and


Cover crops serve many benefits to farmers including reducing soil erosion, reducing nitrogen/nutrient runoff from fields, suppressing weeds, and increasing organic matter. Cover crops improve soil quality, reduce soil compaction, supply nitrogen, increase water infiltration, decrease run-off, conserve soil moisture, and increase yields of crops that follow.

McLemore reports that his cover crop has helped keep his soil intact and not eroding into drainage ditches that run into Turkey Creek Lake—a popular recreation lake in

Franklin Parish. His cover crop has helped increase his farm profits as well by increasing the available nitrogen in the soil, which reduces the amount of nitrogen purchased for spring crops.

Planting cover crops pays big dividends. You keep your soil. You add value to your soil. You protect the quality of the water. You increase your profits.

## NRCS Accepting Applications from Ag and Forestry Producers for EQIP Funding Through Special Initiatives

### Current Ranking Period Ends April 19

The Environmental Quality Incentives Program (EQIP) is a voluntary conservation program that helps agricultural producers improve water and air quality, build healthier soil, improve grazing and forest lands, conserve energy, enhance organic operations, and achieve other environmental benefits.

Applications for EQIP funding are accepted from agricultural and forestry producers at local USDA Service Centers throughout the year in a continuous sign-up process; however, NRCS periodically announces cutoff dates when applications are ranked for funding.

The current EQIP application ranking period for the special initiative funding ends **April 19, 2013**.

Special initiatives offered through EQIP include:

- On-Farm Energy Initiative to help producers conserve energy on their operations;
- Seasonal High Tunnel Initiative to help producers install high tunnels designed to extend the growing season into the cold months, increase productivity, keep plants at a steady temperature and conserve water and energy;
- Organic Initiative to help producers install conservation practices on certified organic operations or those working toward organic certification;
- Mississippi River Basin Healthy Watersheds Initiative to help producers in targeted watersheds improve water quality in the Mississippi River Basin;
- Gulf of Mexico Initiative to help producers in targeted watersheds improve water quality in the Gulf of Mexico;
- Longleaf Pine Initiative to help forest land producers improve the sustainability and profitability of longleaf pine ecosystems;
- Master Farmer Cooperative Conservation Partnership Initiative to help participants of the Louisiana Master Farmer Program implement practices within their existing Resource Management System Conservation Plan and address identified resource concerns;
- Statewide Wildlife EQIP Initiative to focus funding for wildlife conservation; and
- Beginning Farmer/Rancher and Socially Disadvantaged Farmer/Rancher Initiative to focus EQIP funding for historically underserved farmers and ranchers.

**Jan 9-11**

**Louisiana Association of Conservation Districts** - The Louisiana Association of Conservation Districts hosted their 67th annual convention in Baton Rouge, Louisiana on January 9 – 11, 2013. There were 182 people in attendance from across Louisiana. This year's general session focused on the use, management, quality, and quantity of Louisiana water. In addition to the meeting sessions, a special luncheon was held on Thursday, January 12, 2013, recognizing the 33 farmers that were certified as Master Farmers in 2012.

**Ag Expo 2013** - The 31st Annual Ag Expo was held January 18 and 19, 2013, in West Monroe, Louisiana. NRCS exhibited at the expo and provided Farmer Ryan coloring books, soils planners, "When to Plant Conservation Species" posters, and conservation planning brochures to exhibit visitors.

**Irrigation Efficiency Workshop** - The Natural Resources Conservation Service and Caddo Soil and Water Conservation District hosted a one-day irrigation efficiency workshop on February 12, 2013, at the Caddo Extension Service Office in Shreveport, Louisiana. During the workshop, farmers learned how to monitor the efficiency of their current irrigation system, plan a more efficient irrigation system, conserve energy, and recover tailwater/surface runoff. A briefing was provided on the Red Bayou Irrigation Project.

## Washington Parish Producers Visited by Deputy Secretary of Agriculture

### New FSA Loan Program and NRCS Conservation Activities Spotlights

Deputy Secretary of Agriculture Kathleen Merrigan visited Kippy and Kari King in Washington Parish, Louisiana, on February 25, 2013, to spotlight a new Farm Service Agency loan opportunity —the Microloan Program. During her visit, Deputy Secretary Merrigan also commended the Kings on their conservation efforts through the Environmental Quality Incentives Program. This event was covered by local media as well as the Louisiana Farm Bureau Network.

Kippy and Kari King, along with their sons Cody and Kasey, have been in the livestock business for about three years. The Kings started out small with about 15 Brangus type cows on

their 30-acre ranch in Washington Parish, Louisiana. Today, their cow/calf livestock operation has grown to an 80-cow herd on about 300 acres of pasture land; of which 240 acres are leased.

Since taking on the leased land, the Kings have worked with the Natural Resources Conservation Service (NRCS) to implement several conservation practices to make their operation more sustainable and profitable. These practices include pasture renovation, fencing, a livestock watering system, and planting of clover for better forage quality and improved forage utilization by the livestock.

The Kings worked with the Farm Service Agency (FSA) to obtain a microloan for improvements to the farm. They plan to use the microloan funds to purchase several pieces of equipment that will assist in improving the health and fertility of the soil and forages, improve handling facilities for safer working conditions, and increase herd size to utilize all available land resources. Their ultimate goal is to increase the forage availability on the farm which will reduce operating costs and increase income.
